Research-based strategies that all teachers should know

Begin lessons with short reviews of previous learning. Present new material in small amounts; assist students as they practice this material. Ask many questions and observe student responses; questions allow students to connect new material with prior learning. Provide models such as step-by-step demonstrations or think alouds to work out the problem. Guide student practice by asking good questions and providing feedback. Check that students understand the material: doing so can help students learn with fewer errors. Obtain a high success rate (~ 80%) through teaching in small steps. guiding practice, and employing mastery learning techniques. Provide scaffolds, or temporary supports, for difficult material. Prepare students for and monitor independent practice; ample independent 9 practice is necessary for skills and knowledge to become automatic. Engage students in weekly and monthly reviews of past material.
