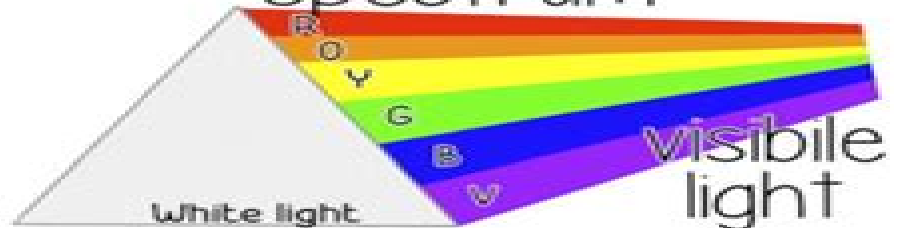

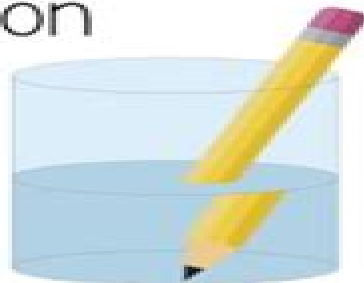

Electromagnetic Spectrum



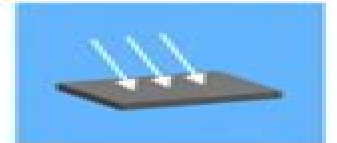
Refraction
