**The Limits of Stabilization** William Easterly, Luis Serven, 2003-10-01 Over the 1980s and 1990s most Latin American countries witnessed a retrenchment of the public sector away from infrastructure provision and an opening up of infrastructure activities to the private sector This book analyzes the consequences of these policy changes from two perspectives First it reviews in a comparative framework the major trends in infrastructure provision in Latin America over the last two decades Second it evaluates the implication of these trends for economic growth and public deficits in the region The book shows that in most countries private participation did not fully offset the public sector retreat The result was a slowdown in infrastructure accumulation which entailed a significant growth cost and weakened the intended impact of the infrastructure spending cuts on public sector insolvency

*The Gold Standard at the Turn of the Twentieth Century* Steven Bryan, 2010 By the end of the nineteenth century the world was ready to adopt the gold

standard out of concerns of national power prestige and anti English competition Yet although the gold standard allowed countries to enact a virtual single world currency the years before World War I were not a time of unfettered liberal economics and one world one market harmony Outside of Europe the gold standard became a tool for nationalists and protectionists primarily interested in growing domestic industry and imperial expansion This overlooked trend provocatively reassessed in Steven Bryan s well documented history contradicts our conception of the gold standard as a British based system infused with English ideas interests and institutions In countries like Japan and Argentina where nationalist concerns focused on infant industry protection and the growth of military power the gold standard enabled the expansion of trade and the goals of the age industry and empire Bryan argues that these countries looked less to Britain and more to North America and the rest of Europe for ideological models Not only does this history challenge our idealistic notions of the prewar period but it also reorients our understanding of the history that followed Policymakers of the 1920s latched onto the idea that global prosperity before World War I was the result of a system dominated by English liberalism Their attempt to reproduce this triumph helped bring about the global downturn the Great Depression and the collapse of the interwar world

*Of Openness and Distance* Ms.Katrin Elborgh-Woytek,2003-10-01 This paper analyzes developments in the structure of trade in the Commonwealth of Independent States CIS during the transition decade and finds that it changed less than in other transition economies Trade openness of the CIS increased between 1993 and 1997 but has fallen to a lower level plateau since then owing to regional and country specific factors These include slower progress in transition geographic aspects restrictions on trade governance and corruption problems weak infrastructure lack of regional cooperation and political conflicts Regression results show that trade openness of the CIS countries would likely increase substantially if market oriented reforms were pursued more vigorously

given the exchange rate stability it provided and Britain's economic predominance. This study draws on a wealth of archival sources and abundant new statistical evidence fully detailed in the appendix to demonstrate that global exchange rate stability always prevailed before the making of the gold standard. This was despite the heterogeneity among national monetary regimes based on gold silver or both. The reason for the stability before the establishment of the gold standard is France's bimetallic system. France, by being in a position to trade gold for silver and vice versa effectively pegged the exchange rate between gold and silver at its legal ratio of 15.5. Part I of the book studies exactly how this mechanism worked. Part II focuses on the respective behaviour of private concerns and arbitrageurs on the one hand and authorities such as the Bank of France on the other hand in order to underline the constraints and opportunities that were associated with bimetallism as an international regime. Finally Part III provides a new view on the collapse of bimetallism and its replacement by a gold standard. It is argued that bimetallism might well have survived and that the emergence of the gold standard was by no means inescapable. Rather it resulted from a massive coordination failure at both national and international levels, a failure that was a preview of the interwar collapse of the gold standard.
