Truth: In terms of profit margins, France's small and medium enterprises outperform Germany's. In France, the profit margin is 3.1 percent; in Germany, it is only 2 percent.

Myth #6: "France is Germany's main trading partner."

Truth: Germany is France's leading bilateral trade partner. But China, and not France, is Germany's top bilateral trade partner.

Myth #7: "Because it is growing faster, Germany must be investing more than France."

Truth: Since 2002, France's total investment-to-GDP ratio - which indicates how much a country is investing in new equipment, technology and research - has been consistently above that of Germany.
