This volume is a collection of essays on ethical, legal, and social aspects of human embryo research. It largely reflects the debate and developments in the state of Victoria, Australia, and in Great Britain in the late 1980's. Published in 1990, the enduring quality of the book's ethical analysis will be very useful to readers where embryo research is debated under public or private auspices. Although the perspective of virtually all contributors favours embryo research with legal and regulatory restrictions to curb abuses, those who oppose embryo research or have not reflected on its impact on received moral beliefs can learn much from the contents of this volume. Any defense of a ban or moratorium on embryo research that did not take account of the array of powerful responses in this volume to arguments against embryo research would be deficient.

Willingness to examine received moral beliefs and to learn from factual, logical, and moral errors is a special mark of civilized debate. The embryo research debate will undoubtedly continue well into the next century, and it will require that those on all sides enter the debate with such willingness. In the United States, an *ad hoc* Panel on Human Embryo Research is only now advising the Director of the National Institutes of Health (NIH) and the Secretary of Health and Human Services (HHS) on this issue. The Panel is working in the context of a moratorium that began in 1975. This book under review has already been valuable to the Panel and to some preparing testimony or papers for the Panel's consideration, including myself.

The volume evolved from a project that began in 1985, when the National Health and Medical Research Council supported a grant to a research team at the Monash University Centre for Human Bioethics to study bioethical issues in the use of human fetal tissue, *in vitro* human gametes and embryos.
