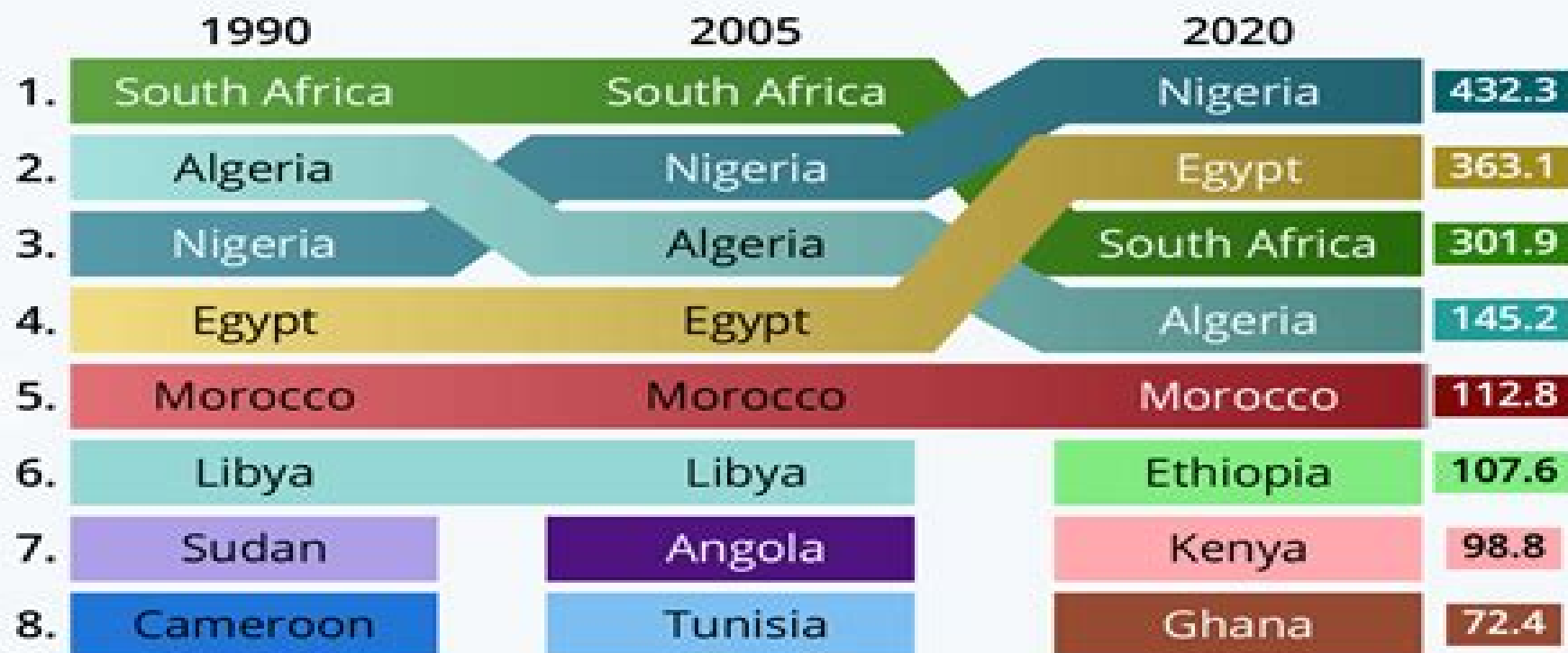


# Africa's Biggest Economies
