Buchanan, 2001 As diverse as the papers presented in this volume may seem at first glance all of them touch on two characteristic themes of James Buchanan's work the respect for individual sovereignty and the threat of monopoly power on the rights of the individual In his foreword Hartmut Kliemt says As opposed to more extreme and more utopian libertarians Buchanan well understands that in our world it takes a state to defend the individual from the state Buchanan therefore is not an anarchist but rather what may be called a reluctant anarchist who accepts both that the state is the greatest threat to individual sovereignty and that without some statelike monopoly individual sovereignty cannot be protected The twenty six essays included in Federalism Liberty and the Law are grouped into these categories The Analytics of Federalism Federalism and Freedom Liberty Man and the State The Constitution of Markets Economists Efficiency and the Law Law Money and Crime The central issue that unites the pieces in this volume is monopoly power and its control As a libertarian Buchanan sees government as the greatest threat and also the greatest protector of individual liberties James M Buchanan 1919 2013 was an eminent economist who won the Alfred Nobel Memorial Prize in Economic Sciences in 1986 and was considered one of the greatest scholars of liberty in the twentieth Public Governance and the Classical-Liberal Perspective Paul Dragos Aligica, Peter J.
