They apply to employers in the private sector that employ at least 15 people in each state, locality, or federal jurisdiction, or who have a federal contract or subcontract that contains the Equal Opportunity clause.

FMLA leave is unpaid, but employers must maintain the employee's group health insurance coverage during the leave. **Who is eligible?**  
Employees are eligible for FMLA leave if they have worked for their employer for at least one year, have worked at least 1,250 hours during the previous 12 months, and work at a location where the employer has at least 50 employees within a 75-mile radius.

Employees can take FMLA leave for the following reasons: the birth and care of a newborn child; the placement with the employee of a child for adoption or foster care; the care of a child with a serious health condition; the care of a spouse, child, or parent with a serious health condition; the employee's own serious health condition; or the death of a spouse, child, or parent.

IT'S THE LAW!**

### All workers have the right to:

- A safe workplace.
- Receive a safety or health concern with your supervisor or OSHA, or report a work-related injury or illness, without being retaliated against.
- Receive information and training on job hazards, including all hazardous substances in your workplace.
- Request a confidential OSHA inspection of your workplace if you believe there are unsafe or unhealthy conditions. You have the right to have a representative (other than OSHA) at your belief.
- Participate in their own representative participation in an OSHA inspection and assist in providing for the inspection.
- File a complaint with OSHA within 30 days by phone, online or by mail if you believe a work-related injury or illness.
- Use any OSHA resources issued to your employer.
- Request copies of your medical records, tests, and maximum exposure in the workplace, and the workplace injury and illness log.

### Employers must:

- Provide employees a workplace free from recognized hazards. It is illegal to retaliate against an employee for using any of their rights under the law, including testing in health and safety concerns with you or with OSHA, or reporting a work-related injury or illness.
- Comply with all applicable OSHA standards.
- Supply OSHA within 15 days of a workplace injury or within 15 days of any work-related incident, hospitalization, amputation, or loss of an eye.
- Provide required training to all workers in a language and vocabulary they can understand.
- Prominently display this poster in the workplace.
- Post OSHA violations at or near the place of the alleged violation.

OSHA's On-Site Consultation services are available to small and medium-sized employers, without citation or penalty, through OSHA's national consultation program in every state.
