

## RECOGNITION OF WRITING CHARACTERISTICS

### HANDWRITING STROKE

**STROKE** is a series of lines or curves written in a single letter, one of the lines of an alphabet or series of lines or curves within a single letter; the path traced by the pen on the paper.

1. **ARC OR ARCH** – a curved formed inside the top curve of loop as in small letters "h", "m", "n", & "p".



2. **ASCENDER** - is the top portion of a letter or upper loop.

3. **BASELINE** - maybe actually on a ruled paper, it might be imaginary alignment of writing; is the ruled or imaginary line upon which the writing rests.

4. **BEADED** - Preliminary embellished initial stroke which usually occurs in capital letters.

5. **BEARD** - is the rudimentary initial up stroke of a letter.



6. **BLUNT** - the beginning and ending stroke of a letter (without hesitation).



7. **BODY** - The main portion of the letter, minus the initial of strokes, terminal strokes and the diacritic, of any. Ex the oval of the letter "O" is the body, minus the downward stroke and the loop.



8. **BOWL** - a fully rounded oval or circular form on a letter complete into "O".

9. **BUCKLE/BUCKLEKNOT** - A loop made as a flourish which is added to the letters, as in small letter "k & b", or in capital letters "A", "K", "P"; the horizontal end loop stroke that are often used to complete a letter.
