- Outright repeal of ACA highly unlikely given presidential veto and Democratic majority in Senate.
- House Republicans likely to hold “symbolic” repeal vote and pursue targeted strategies to limit ACA implementation.
- House floor votes likely on unpopular portions of health reform (e.g. 1099 tax filing mandate and medical device fees).
- Republicans are likely to attempt to use appropriations process to prevent HHS from implementing key ACA provisions.
- Congressional Review Act joint resolutions.
- Aggressive use of House subpoena power — oversight investigations and hearings.
- Key GOP themes – ACA impact on employers, health care premiums and cost, health care innovation, and seniors.
