The traditional approaches to price regulation will not have the intended effect of eliminating excess profits from the industry while maintaining the incentives for research and development. First-rate of return regulation, the most natural approach, would result in many adverse incentives, including excessive investment in research and development in order to inflate the rate base used to calculate the allowable returns.
