Although the perspective of virtually all contributors favours embryo research with legal and regulatory restrictions to curb abuses, those who oppose embryo research or have not reflected on its impact on received moral beliefs can learn much from the contents of this volume. Willingness to examine received moral beliefs and to learn from factual, logical, and moral errors is a special mark af civilized debate. The embryo research debate will undoubtedly continue well into the next century, and it will require that those on all sides enter the debate with such willingness. In the United States, an ad hoc Panel on Human Embryo Research is only now advising the Director of the National Institutes of Health (NIH) and the Secretary of Health and Human Services (HHS) on this issue. The Panel is working in the context of a moratorium that began in 1975. This book under review has already been valuable to the Panel and to some preparing testimony or papers

for the Panel's consideration, including myself.
