

ism," and even "Marxism." While presenting us with a cursory survey of Quebec's political, social, and economic history for the past four decades, the authors raise the possibility that nationalism "or the national sentiment of les Québécois ... gives the workers of Quebec a possible linguistic and cultural basis to the development of a revolutionary class consciousness" (238-9). Other, more puzzling, statements include "it [ethnicity] is a mathematical measure of the direct socio-economic consequences of Quebec's colonial status, the oppression of its people" (63), or "if workers in Marx's time did not have a country, they often do today" (97), or "... this final chapter has added to the description of [American] economic imperialism the dimension of ideology, that is, how the status quo is defended by liberal intellectuals" (100).

Although this book is woefully simplistic (but full of noble sentiments), it does have certain merit. The authors have undertaken substantial research, utilizing various primary sources in French Canada's social history. The second half of the book in particular is a valuable summary of literature not readily available to most English-Canadian readers and, in this sense, the authors have rendered us a service. It is, however, to be regretted that *The Decolonization of Quebec* was not condensed into a more cryptic essay of lesser length but more complex thought.

One of the significant conclusions one can draw from the publication of these two books on Quebec politics is that Canadian political scientists must begin to undertake a further, new type of collective research. It is not sufficient that one proceed to a proliferation of further studies on the politics of various provinces. It is necessary to begin to undertake collaborative comparative research projects which mesh together various provincial political studies. In order to overcome what appears as a developing "provincialism" in Canadian political science, a new comparative "inter-provincialism" must be fostered and generated.

Robert Presthus, *Elite Accommodation in Canadian Politics*. Toronto: Macmillan of Canada, 1973, pp. xii, 372.

This is an ambitious book on an important topic. It presents the results of a large-scale research effort designed to "document a theory of political behaviour which may

help explain the Canadian process of government and the vital role of groups in that process." A broad interpretation of the policy process and the part played by groups are indeed both sorely needed. Unfortunately, however, Presthus fails to meet adequately his goals and the need remains unfulfilled. The book, while presenting much useful and interesting data, suffers from major weaknesses in theory, method, style, and presentation.

Presthus sets out to explore two major theoretical streams. First is the elite accommodation model developed by Arend Lijphart, which asks how harmony may be attained in a society characterized by deep subcultural cleavages. Second is the view that in modern industrial societies, the imperatives of complexity and differentiation require that policy be developed through a process of close interaction between organized groups and government officials. Both purposes are served by what Presthus sees as the dominant pattern of decision-making in Canada. Interest groups play a central - if not the dominant - role in policy-making. Their contribution "is probably as important as that of the elites who direct the formal political apparatus." Government leaders are primarily brokers, and "one would be hardpressed to find any significant policy or programme conceived independently by governmental elites." Policy is thus a product of a "symbiotic interaction" in which interest-group heads, senior officials, and politicians bargain with each other in a generally consensual, cooperative, mutually rewarding way. The three groups share broadly similar social and economic origins, substantive ideologies, and views about the appropriate role of government. Allocation of resources by the three elites goes on essentially free of mass constraints, since he argues it takes place within a mass political culture which is "quasi-participative" and in which attitudes toward authority legitimize the "bureaucratic virtues of order, deference, hierarchy, security and collective limitations of individual autonomy." Corporatist, organicist, and pragmatic elements in the culture, he suggests, also facilitate the group process.

The bulk of the book examines the nature of this process through the eyes of group and government participants. Presthus looks at the structure of groups, their political resources and tactics, their perceptions of the role they play in policy formulation, and their political effectiveness. He also examines the ideological and socio-economic linkages between the various elites, depending here primarily on Ho-
