Common Market as in most other integration schemes among less developed countries the main expectations regarding the promotion of economic growth are based on the expectation of increased opportunities for import substituting industrialization. The concern here is with the Andean Common Market in particular because it has been the economic integration scheme that has most explicitly recognized the objective of the less developed countries of taking advantage of the new opportunities for industrialization created by the combination of the individual markets. In the Andean Common Market the importance attached to the expectation of the gains from industrialization was expressed in the formulation of Sectorial Programs of Industrial Development.
