All workers have a right to work in places where risks to their health and safety are properly controlled. Health and safety is about stopping you getting hurt at work or ill through work. Your employer is responsible for health and safety, but you must help.



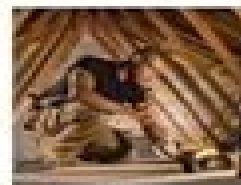
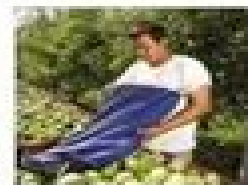
What employers must do for you

- 1 Provide what could harm you in your job and the precautions to stop it. This is part of risk assessment.
- 2 In a way you can understand, explain how risks will be controlled and tell you who is responsible for this.
- 3 Consult and work with you and your health and safety representative in preparing everyone from harm in the workplace.
- 4 Tell of changes that pose the health and safety risk that you need to do your job.
- 5 Tell of changes that pose the health and safety risk that you need to do your job.



What you must do

- 6 Provide safety, working facilities and drinking water.
- 7 Provide adequate first aid facilities.
- 8 Report major injuries and fatalities at work to the Health and Safety Executive (HSE) on 0845 300 9000. Report other injuries, diseases and dangerous occurrences on www.hse.gov.uk.
- 9 Have insurance that covers you in case you get hurt or sick or if things go wrong. Display a hard copy or electronic copy of the current Insurance Certificate which you can easily read to.
- 10 Work with any other employees or contractors sharing the workplace in preventing workplace risks to injury, sickness or that someone's health and safety is put at risk.
