# Domestic Politics in EU External Economic Relations: US-EU Competition in Trade

#### 1 Introduction

During the past decade, the world trading system has undergone a profound transformation. On the one hand, the uncertainty surrounding of the conclusion of the Doha Development Agenda (DDA) within the institutional framework of the World Trade Organisation (WTO) has dampened confidence among countries about the multilateral approach to trade liberalisation. On the other hand, free trade agreements (henceforth FTAs)<sup>1</sup> whereby members exchange preferential market commitments are proliferating.<sup>2</sup> In this "market and competition oriented" environment (Schirm 2002, p. 2; Baccini and Dür 2012, p. 57) with "its emphasis on exports and open markets" (Thiel 1998, p. 61) as hallmarks of the so-called 'new regionalism' (Ethier 1998, pp. 1150–1152), FTAs have become the prominent
