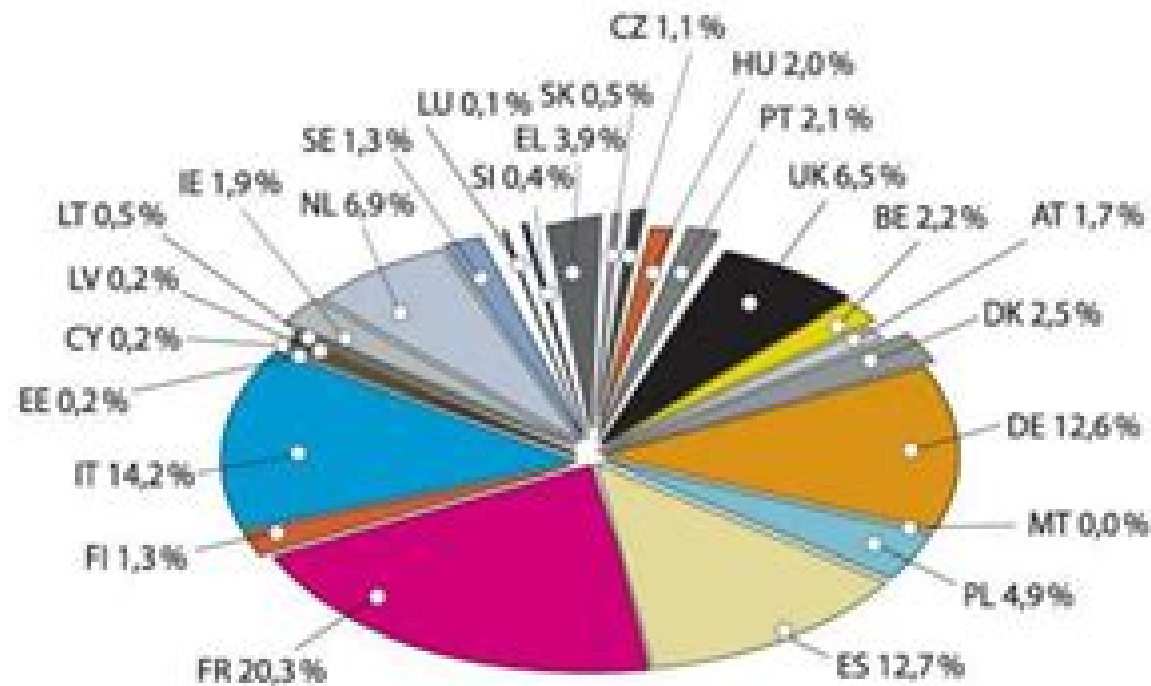

opposition But the reform of the European Union s Common Agricultural Policy CAP in 1992 and the 1996 Farm Bill in the United States seems to have ushered in a new era of relations between government and agricultural groups The author points out ways that multilateral regional and unilateral paths could be coordinated to liberalized agricultural trade He proposes a set of multilateral talks that would benefit from agricultural reform at all levels and complete the job begun at the Uruguay Round
